This Agreement annuls and voids all previous agreements.

OVERVIEW

The Site (FunGal.Farm) is operated by FunGalFarm. Throughout the Site, the terms "**we**", "**us**" and "**our**" refer to FunGalFarm. FunGalFarm offers this Site, including all information, tools and services available from this Site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

SECTION 1 - GENERAL TERMS
